### INTRODUCTION

#### OFFER THE PATIENT HIGH LEVEL MANAGEMENT

The aim of the ERN-Skin is to offer patients highly specialised healthcare and support in their daily care while enabling them to remain in their home environment.

The ERN-Skin healthcare providers via the 9 ERN-Skin thematic groups and the Skin ePAG worked together

- to assess, endorse, actualize, adapt or develop guidelines to improve diagnosis and management.
- to develop clinical decision tools to help healthcare providers and patients to face the day to day management and care

The ERN-Skin conducted additional activities not initially planned in the project but part of the ERN coordinator group (ERN coordinator group on Clinical Guidelines and Knowledge Generation) and of the European Commission programme to support the ERN (CPGs and CDSTs Programme).

## **OBJECTIVES**

- To provide high level patient management for every condition covered by the ERN-Sin
- To identify available guidelines and recommendations at the ERN-Skin level, at the ERN level, at the Scientific Societies level, at patient support group level
- To elaborate an ERN-Skin methodology for developing / accrediting these guidelines and recommendations
- To share and spread harmonized best practices thanks to the adaptation and development of guidelines and recommendations for health care professionals

#### 1. GUIDELINES

The ERN-Skin thematic/disease groups, as well as specialists, paramedical staff and patient groups work together according to complementary approaches:

- Guidelines endorsed by the ERN-Skin: each disease group assess the available guidelines at the local and national level. When complying with standard evidence-based procedure, the ERN-Skin board via each disease group endorses these guidelines.
- Guidelines elaborated with the participation an ERN-Skin or several members: An ERN-Skin or several
  members contribute to the development of a new guideline with other healthcare providers, European task
  forces or networks such as the European Academy of Dermatology and Venereology Task Force or the
  European Dermatology Forum
- Guideline developed by an ERN-Skin or several members and then endorsed by the ERN-Skin thematic group: the guideline is first developed at the national level. Then, the ERN-Skin disease group assess the guideline and endorses it.
- Guidelines developed by the ERN-Skin. These guidelines follow the standard evidence-based procedure by
  involving multidisciplinary group of experts, analyzing literature and taking into account experience of
  experts, including SKIN ePAG advocates. They are updated every 5 years or before in case of therapeutic
  innovation.

### 2.1. EMERGENCY CARDS

#### **DEFINITION**

Emergency cards have all the essential information on the management of the patient with a rare skin disease. They are produced by the ERN-Skin experts, along with SKIN ePAG advocates. Rare skin diseases are unknown to most medical staff. In an emergency situation, it is vital to provide adequate care to avoid any complications. These emergency cards are the size of a business card and are written in the national language so that patients can carry them at all times.

#### 3. HEALTHCARE PATHWAYS AND PATIENT JOURNEYS

# 3.1. Understand the Healthcare pathways and patient journeys

The healthcare pathway is the patient's journey through the healthcare system. It refers to all the stages a patient experiences in the management of his or her disease, from pre-diagnosis to palliative care.

## 3.2. THE PATIENT JOURNEYS' DEFINITION AND METHODOLOGY

#### **DEFINITION**

Patient Journeys are visual testimonies that reflect the natural history/needs of patients and their families for a specific rare disease. They represent the collective perspective on the burden of the disease and the needs of people with first-hand experience of living with a rare skin disease.

#### It aims to:

- Engage the wider patient community to consolidate common needs for a specific rare disease
- Engage in a discussion with the clinicians to highlight the different (unmet) needs of a specific rare disease, both medical and psychological, so the clinicians can respond to these needs
- Keep in mind both the professional and patient are experts

#### **METHODOLOGY**

The patient journey methodology is

- Mapping the journey and identifying the needs and recommendations on ideal care for each specific skin disorder across the different stages from the first symptoms at birth to the end of life care
- Reviewing by both ePAG advocates and clinical experts (clinical presentation validated by some clinicians)
- Organising the information in easy reading graphics (table and illustration)
- Identifying the needs that are common for all 'skin disorders' (to be develop in the next steps)

## 3.3. THE ERN-SKIN PATIENT JOURNEYS

#### THE KEY ROLE OF THE SKIN EPAG

European Patient Advocacy Groups (ePAGs) bring together rare disease patient advocates who are actively involved in the work of the European Reference Networks. Each ePAG has a number of 'ePAG advocates', who represent their disease area in the ERN and the interests of the wider patient community.


The Skin ePAG is the ePAG advocate group of the ERN-Skin. Each member is a representative of a patient organisation. Within the ERN-Skin, ePag advocates are present in each thematic and transversal group and play a key role in governance.

The Skin ePAG have developed the patient journeys with the support of some thematic groups.

# 4.2. RECEIVE SUPPORT FROM THE CPGS AND CDSTS PROGRAMME

In the framework of the ERN Clinical Practice Guidelines (CPGs) and Clinical Decision Support Tools (CDSTs) Program, the ERN-Skin has conducted a survey among the 9 ERN-Skin thematic groups to prioritize the diseases for which healtcare providers and patient need the most CPG and CDST development or revision.

The ERN-Skin thematic group identified

- 7 CPG to develop:
  - o Palmo-plantar keratoderma
  - Syndromic Hidradenitis
  - P63 related ectodermal dysplasias
  - o Cutis laxa
  - o Pseudoxanthoma elasticum
  - o Ehlers-Danlos syndrome

  - o Poikiloderma
  - Bullous pemphigoid
- 3 CDST to revise:
  - Inherited ichthyosis
  - Syndromic Hidradenitis
  - Bullous pemphigoid

The next step is to develop guidelines for each condition covered by the ERN-Skin. To have a real impact, the ERN-Skin has to

- Hire additional staff: a methodologist and medical writer
- Engage national, European and international scientific societies and other ERNs
- Organize expert meetings
